### Application Area

### Product Description

GREVEN<sup>®</sup> Active Force MP is a strong hand cleanser with natural scrubbing agents made of olive seed powder for the thorough but gentle removal of heavy dirt. The thick heavy-duty hand cleanser is adapted to the natural pH-value of the human skin and is solvent-free. GREVEN<sup>®</sup> Active Force MP in 2000 ml collapsible bottles has been awarded the EU Ecolabel.

### Product Properties

- The formulation of GREVEN<sup>®</sup> Active Force MP almost perfectly combines high cleansing power, excellent skin compatibility and environmental soundness.
- In this regard, the surfactant combination is a highly contributing factor. The surfactants contained are very mild and produced from sustainable sources; they improve the skin compatibility of the product considerably.
- The cleansing effect of the product is supported by olive seed powder, whose grain structure is especially adapted to this type of use. Due to its low specific weight, blockages of drains and pipes are not to be expected.
- The rape seed oil contained supports the cleansing power of the product and helps to prevent skin irritation due to its lipid-balancing effect.
- The pH-value of the product has been adapted to the natural acid mantle of the human skin, which in its functions is not affected by the product.

### Application

Apply GREVEN<sup>®</sup> Active Force MP evenly on the dry skin. Continue washing adding little water. Rinse off with plenty of water and dry hands thoroughly. If the product gets into the eyes, rinse thoroughly with plenty of water.

### Certificate of Dermatological Compatibility

The dermatological compatibility of GREVEN<sup>®</sup> Active Force MP has been carefully tested and proven. A printed certificate is available.

### Product Quality

GREVEN<sup>®</sup> Active Force MP is manufactured according to GMP (Good Manufacturing Practice) requirements which include the most recent EU guidelines.

### Ecology

The surfactants used fulfil the requirements of easy biological degradability as they are determined in the Regulation (EC) No 648/2004 on detergents. The laboratory testing of surfactants in the context of this regulation is based on the "Confirmatory Test" procedure of the OECD method.

### Environment

All bottles are made of polyethylene and after being completely emptied, they can be disposed of with other polyethylene waste. Packaging is labeled accordingly. The surfactants used are biodegradable and fulfil the legally required minimum degradability of 90 %.

### Storage Instructions

GREVEN<sup>®</sup> Active Force MP will keep for at least 30 months (from date of manufacture) if stored unopened at room temperature in the original packaging. The Period After Opening (PAO) is indicated on each bottle.
