Application Area

GREVEN[®] Active Pearls[®] is especially suitable for the removal of heavy dirt, e.g. from grease, oil, metallic dust, graphite or soot.

Product Description

GREVEN[®] Active Pearls[®] is a hand cleanser for heavy dirt, but does not contain sharp-edged scrubbing agents. Due to the innovative and patented dirt-removing agent Active Soft Pearls[®] (ASP), the product GREVEN[®] Active Pearls[®] has a strong cleansing effect but at the same time, it is gentle to the skin.

Product Properties

- The innovative dirt-removing agent Active Soft Pearls[®] (ASP) supports the cleansing effect of the surfactant combination not by mechanical abrasion, as conventional scrubbing agents would do, but by their lipophilic surface structure which is able to bind greasy dirt particles.
- The soft and smooth pearls made of hydrogenated castor oil (wax) can remove dirt particles without affecting the skin.
- Rather: waxes are preferentially used in skin care products because of their gently caring and smoothing effect.
- GREVEN[®] Active Pearls[®] combines ASP with a highly effective surfactant combination.

Application

Apply GREVEN[®] Active Pearls[®] evenly on the dry skin. Continue washing adding little water. Rinse off with plenty of water and dry hands thoroughly. If the product gets into the eyes, rinse thoroughly with plenty of water.

Certificate of Dermatological Compatibility

The dermatological compatibility of GREVEN[®] Active Pearls[®] has been carefully tested and proven. A printed certificate is available.

Product Quality

GREVEN[®] Active Pearls[®] is manufactured according to GMP (Good Manufacturing Practice) requirements which include the most recent EU guidelines.

Ecology

The surfactants used fulfil the requirements of easy biological degradability as they are determined in the Regulation (EC) No 648/2004 on detergents. The laboratory testing of surfactants in the context of this regulation is based on the "Confirmatory Test" procedure of the OECD method.

Environment

All bottles are made of polyethylene and after being completely emptied, they can be disposed of with other polyethylene waste. Packaging is labeled accordingly. The surfactants used are biodegradable and fulfil the legally required minimum degradability of 90 %.

Storage Instructions

GREVEN[®] Active Pearls[®] will keep for at least 30 months (from date of manufacture) if stored unopened at room temperature in the original packaging. The Period After Opening (PAO) is indicated on each bottle.
