## Application Area

GREVEN® Active Ultra AB is especially suitable for the removal of highly-adhesive dirt, e.g. from varnish, resins, adhesives and paint.

## Product Description

GREVEN® Active Ultra AB is a special hand cleanser with dirt-removing additives and natural scrubbing agents made of olive seed powder.

## Product Properties

- GREVEN® Active Ultra AB is used when common skin cleansing agents based on surfactants fail to perform.
- Varnish, resins, adhesives, bitumen and similar heavily water-repellent dirt cannot be removed from the skin by the mere use of surfactants. Therefore, organic solvents are still used often for these purposes. GREVEN® Active Ultra AB contains ester oils as dirt-solving component because of their very good skin compatibility.
- The cleansing effect of the product is supported by olive seed powder, whose grain structure are especially adapted to this type of use. Due to its low weight, blockages of drains and pipes are not to be expected.
- The entire formulation as well as the pH-value of the product has been adapted to the natural acid mantle of the human skin, which in its functions is not affected by the product.
- Lipid-replenishing ingredients provide an additional caring effect.

## Application

Apply GREVEN® Active Ultra AB evenly on the dry skin. Continue washing adding little water. Rinse off with plenty of water and dry hands thoroughly. If the product gets into the eyes, rinse thoroughly with plenty of water.

The dermatological compatibility of GREVEN® Active Ultra AB has been carefully tested and proven. A printed certificate is available.

## Product Quality

GREVEN® Active Ultra AB is manufactured according to GMP (Good Manufacturing Practice) requirements which include the most recent EU guidelines.

## Ecology

The surfactants used fulfil the requirements of easy biological degradability as they are determined in the Regulation (EC) No 648/2004 on detergents. The laboratory testing of surfactants in the context of this regulation is based on the "Confirmatory Test" procedure of the OECD method.

## Environment

All bottles are made of polyethylene and after being completely emptied, they can be disposed of with other polyethylene waste. Packaging is labeled accordingly. The surfactants used are biodegradable and fulfil the legally required minimum degradability of 90 %.

## Storage Instructions

GREVEN® Active Ultra AB will keep for at least 30 months (from date of manufacture) if stored unopened at room temperature in the original packaging. The Period After Opening (PAO) is indicated on each bottle.
